Due to repeated health issues for our client, the building was vacant for a long period of time, thus earning no rental income. While our client worked on rehabbing the property over the course of several years, he experienced another setback while trying to get the building inhabitable again. Due to a water main break, all of the apartments that he had rehabbed were destroyed, and had to be stripped down to nothing. Working with the client on the tax return we were able to take deductions, and make necessary adjustments to save the client nearly \$60,000 in capital gains.
