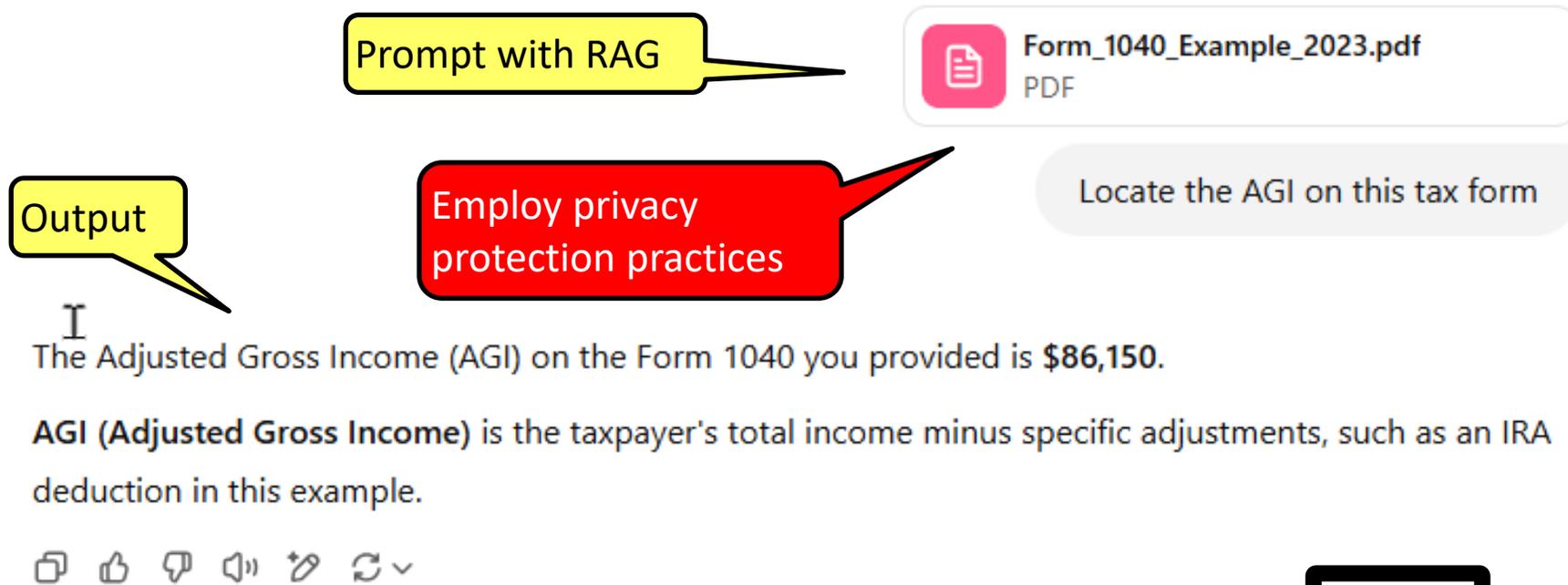


A Simple Generative AI demo

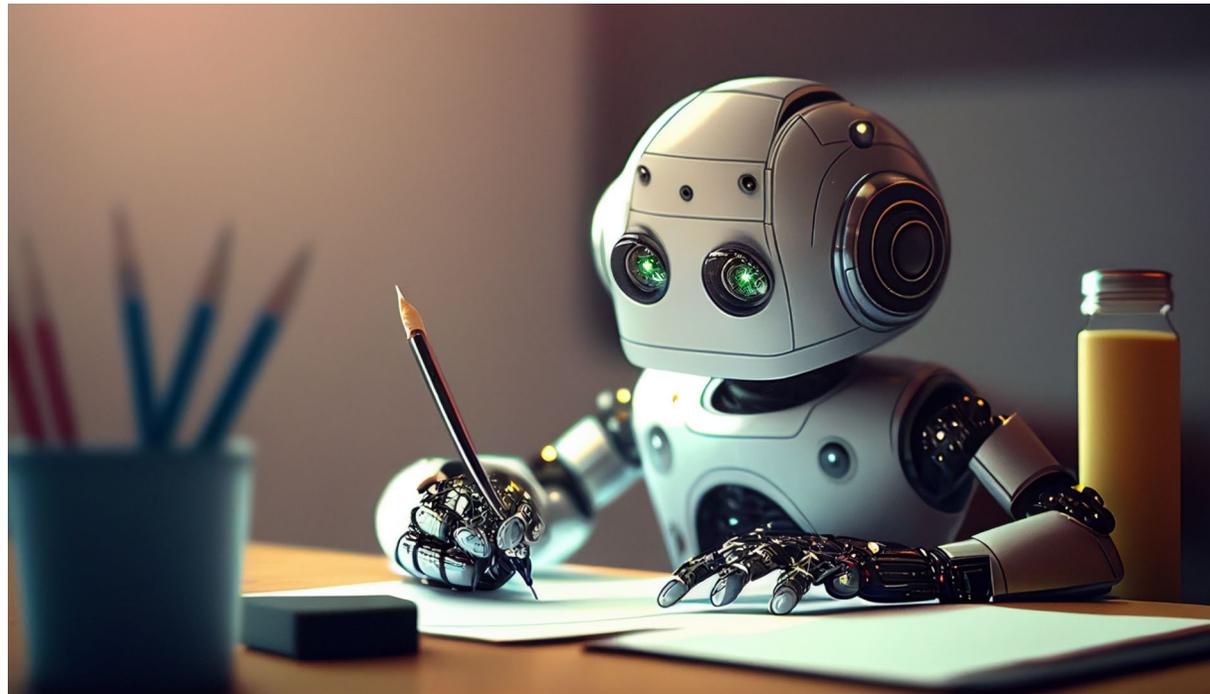
Sample Prompt for Financial Statement Analysis

- Analyze the attached NVIDIA financial statements, including the income statement, balance sheet, and cash flow statement.
- Identify key financial metrics, trends, and potential risks. Provide insights on revenue growth, profitability, liquidity, solvency, and cash flow management.
- Highlight any significant changes year-over-year and compare them to industry benchmarks if possible.

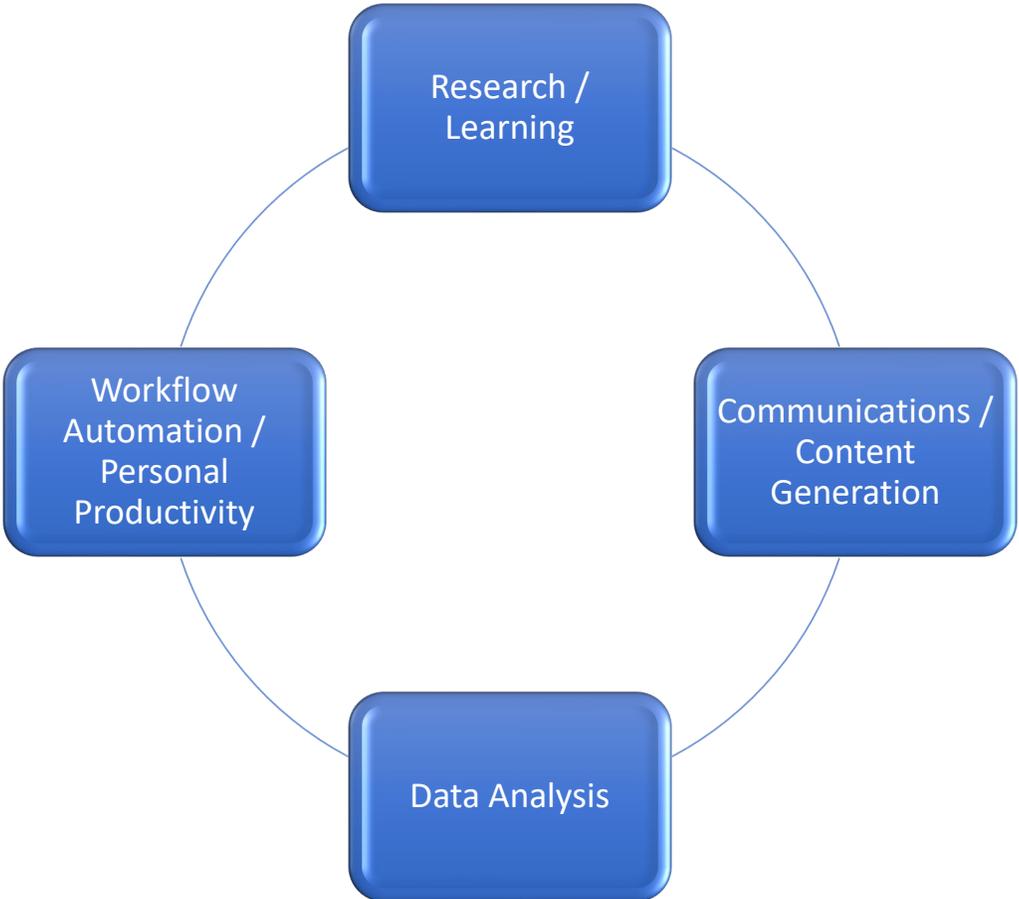

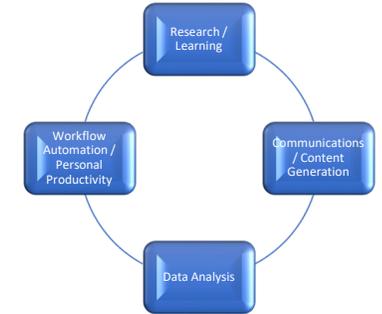

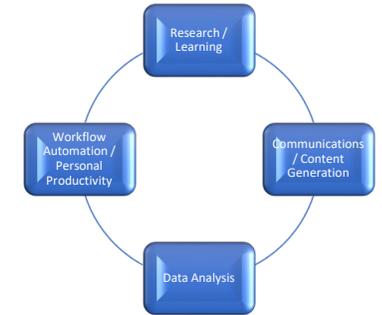
AI Applications in Accounting Services



- Research an accounting standard
- Design a chart of accounts
- Create a job description for a staff accountant
- Create a quiz to screen bookkeepers

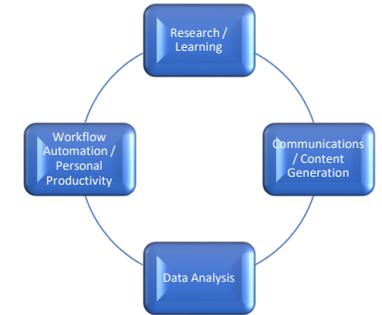
Create a 20-question quiz to assess candidates applying for a position as a bookkeeper in our small car wash business. The job duties include payroll processing, invoicing and accounts receivable, purchases and accounts payable, fixed asset reporting and preparation of monthly financial statements. Include questions requesting their name and email address. Make the questions multiple choice. All questions require an answer

AI Applications in Tax Services



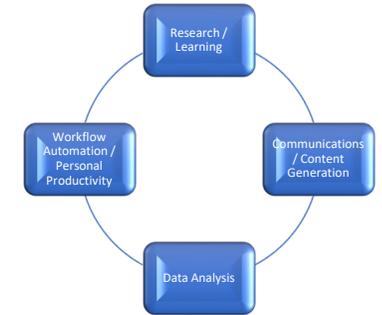
- Research a complex tax scenario
- Analyze a tax return
- Organize incoming 1040 source documents

AI Applications in Auditing Services



- Identify required footnote disclosures
- Develop an audit program
- Analyze contracts / lease agreements
- Develop audit workpapers

AI Applications in Advisory Services



- Conduct industry research
- Define an advisory service offering
- Develop service delivery process
- Create a marketing communications plan

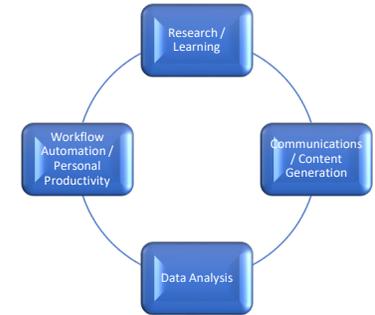

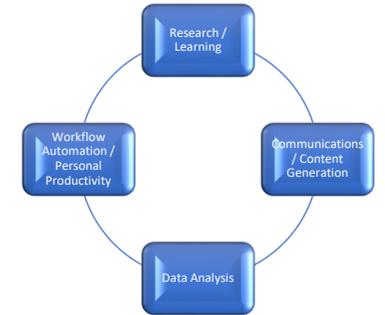

Research & Learning Applications



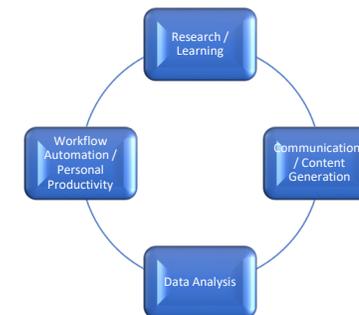
- Tax research

Communications & Content Generation Applications



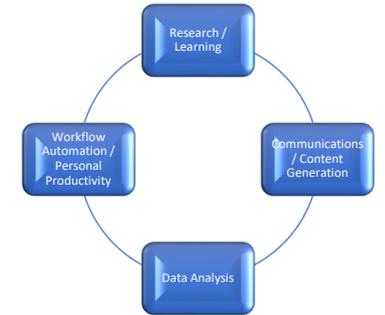
- Explain a complex tax strategy to a lay person
- Generate talking points for a client meeting
- Develop a presentation of financial statements for a non-profit board of directors
- Create content for a website
- Develop an AI usage policy for your company

Data Analysis Applications



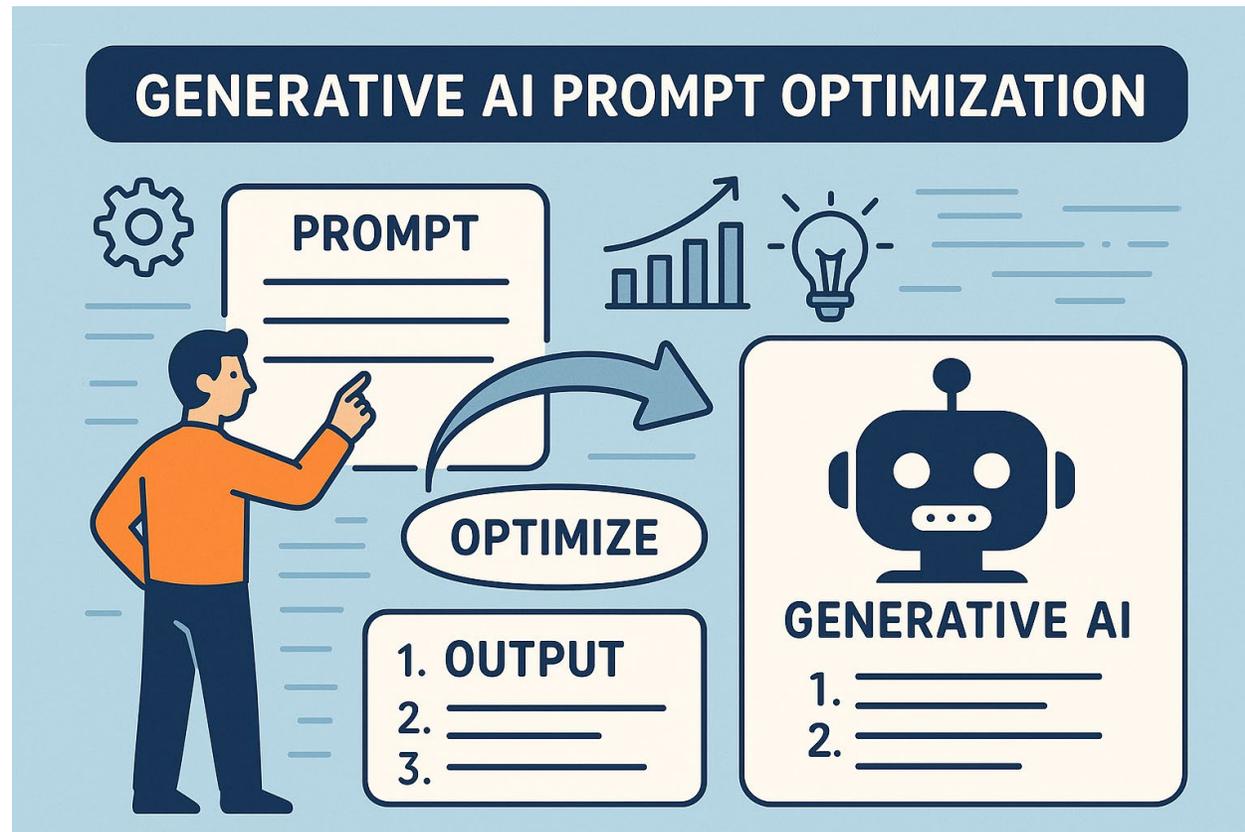
- Analyze financial reports to extract key metrics
- Analyze transaction ledgers for fraud
- Analyze contracts and leases in a financial audit
- Analyze historical financial data to predict future performance
- Analyze terms of a business transaction to determine the tax implications

Workflow / Personal Productivity Applications

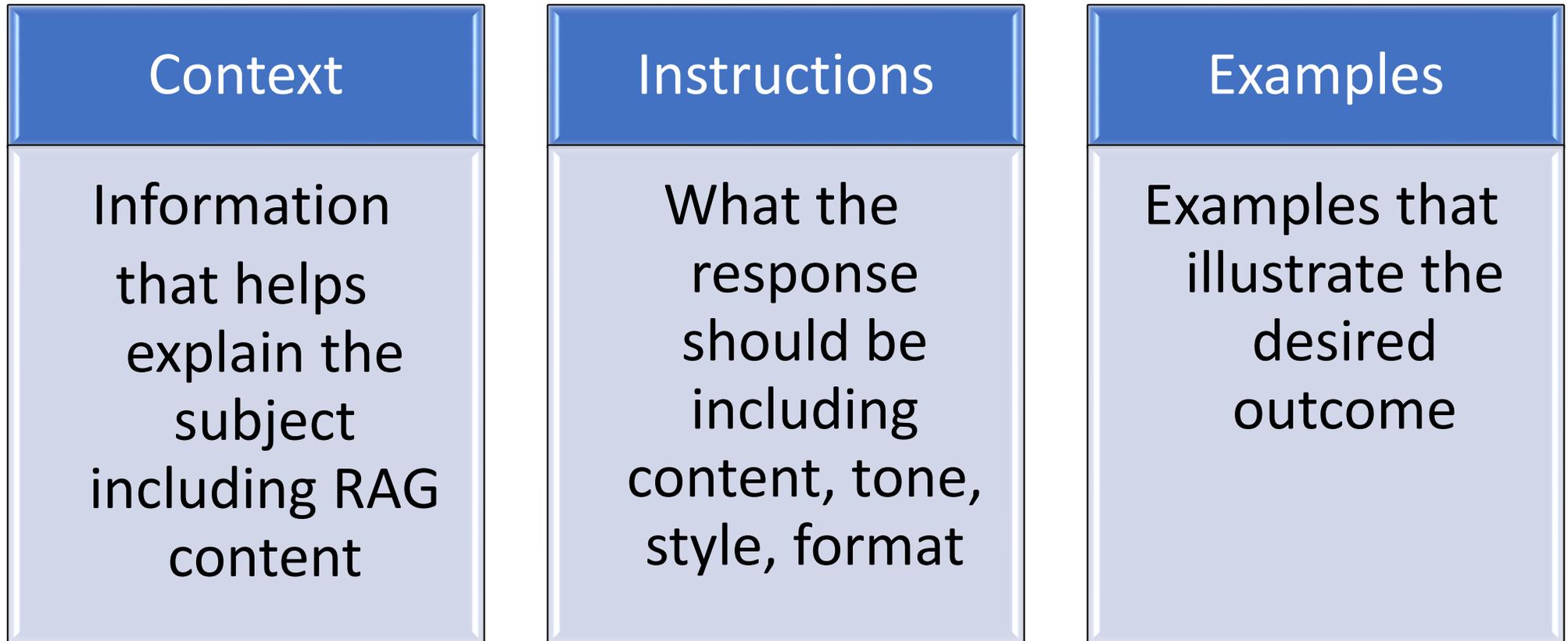


- Develop Excel macros to automate routine tasks
- Compose / reply / analyze / organize emails
- Document and summarize online meetings
- Develop custom applications to automate routine tasks

PROMPT OPTIMIZATION



“Prompt” Components



Best Practices for Effective Prompts

- *Clarity* – use clear and concise language
- *Specificity* – be specific about the task and output
- *Conciseness* – Focus on essential details only
- *Iteration* – Test and adjust prompt as appropriate
- *Define Terms* – Spell out acronyms

RAG (Retrieval Augmented Generation)

- “Retrieve” relevant information from external sources
- “Augments” the prompt
- “Generation” by AI utilizing the prompt and retrieve content
- Examples; documents, images, websites

SBAR Prompt Methodology

- Situation – What’s going on?
- Background – What is the context?
- Assessment – What do you think the problem or need is?
- Recommendation – What action or output do you want from the AI?

SBAR Prompt Example

S: I need help communicating with a client about an accounting standard.

B: The client is a construction company with multiple equipment leases. They're not familiar with ASC 842.

A: They may not understand how the new rule affects their balance sheet and financial disclosures.

R: Write a professional email that explains ASC 842 in simple terms and outlines the financial reporting impact for 2025.



SBAR Prompt Example

Dialectic Prompt Methodology



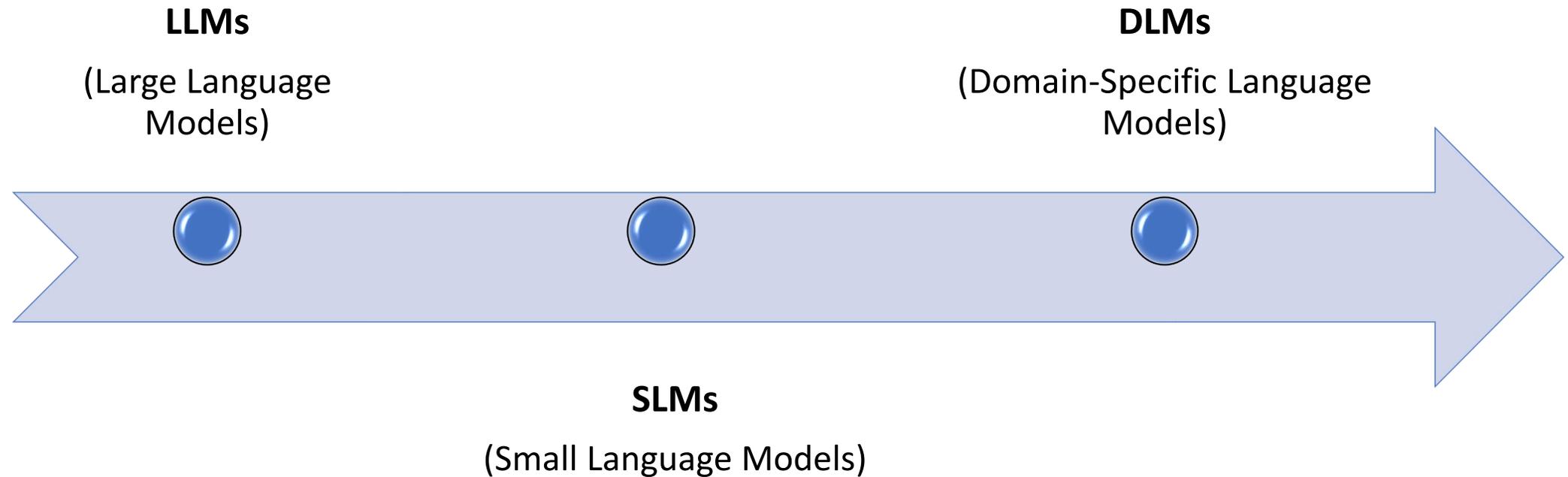
Dialectic Prompt Example

- Based on the Socratic method encouraging deeper understanding through dialogue
- **Thesis** – Start with an initial statement or prompt
- **Antithesis** – Challenge the initial response with a counterpoint or follow-up questions
- **Synthesis** – Refine the idea by combining insights from both the thesis and antithesis

Factors to Consider

- ✓ Scope of potential applications
- ✓ Integration with existing apps / data sources
- ✓ Availability of AI in existing apps
- ✓ Budget allotment

IDENTIFYING AI OPPORTUNITIES IN YOUR ORGANIZATION



Step 1 – Form a Team

- Establish an AI project team
- Include representation across the organization
- Invest in AI tool(s) and training for the team
- Set goals / objective / timeline for the team

Step 2 – Assess Business Processes

- Identify repetitive, document-heavy, or decision-driven tasks
- Interview process leaders to identify pain points and bottlenecks
- Map use cases to AI capabilities
 - ✓ Document drafting
 - ✓ Data summarization
 - ✓ Idea generation
 - ✓ Process automation

Step 3 – Evaluate Specific Initiatives

- Time savings
- Cost reduction
- Increased accuracy
- Data availability
- User adoption

Step 4 – Get Started!

- Select and prioritize initiatives
- Procure AI tool(s)
- Obtain training
- Start with a pilot project
- Conduct ongoing assessment and evaluate
