► Civil Tax Defense

We represent taxpayers in all types of civil tax disputes, including income tax, estate and gift tax, payroll tax, excise tax, sales tax, and assessable penalties. We always work to resolve tax disputes without litigation – it is private, it is less expensive, and it is less stressful. We are able to negotiate a favorable settlement in most of our cases, however, if we are not able to do so, we are ready to go to trial. Our team has served as lead counsel in the **U.S. Tax Court, Federal District Courts, the Court of Federal Claims**, and multiple **U.S. Courts of Appeals**, including the Seventh, Eleventh, and D.C. Circuits. We have also represented *amici* before the **Supreme Court of the United States**.

► Criminal Tax & White Collar Defense

Our criminal defense team has secured incredible results in criminal tax and white-collar defense. Most of this work never becomes public—because the goal is to resolve cases quietly, cooperatively, and without charges. In 2025 we were able to convince the government not to prosecute our clients in over 80% of the applicable cases.

If charges cannot be avoided, we secure the best possible path forward, whether negotiating a creative plea agreement or proceeding to trial. In 2023, we secured a **complete acquittal** after a twelve week federal jury trial in the Northern District of Georgia—an outcome achieved in a system where fewer than 1% of federal defendants are acquitted. So far in 2026, we have fought for and received a sentence of probation for all guilty pleas this year.

The U.S. tax system relies on voluntary compliance. When disputes arise, taxpayers deserve fair treatment, accurate application of the law, and strong advocacy.

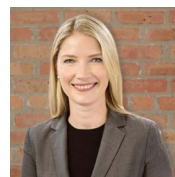
